# **Declaration of Consent**

This document has been prepared to ensure compliance with data protection laws. ### 1. Introduction

My website, <a href="https://technische-uebersetzungen-eva-schwarz.de">https://technische-uebersetzungen-eva-schwarz.de</a> (hereinafter: "The Website") uses cookies and similar technologies (for convenience, all of these are collectively referred to as "cookies"). Cookies are also placed by third parties I commissioned. In the following I inform you about the use of cookies on my website:

### 2. What are cookies?

A cookie is a simple small file that is sent together with the pages of an internet address and can be stored by the web browser on the PC or other device. The information stored there-in may be sent to my provider's servers or relevant third party servers during subsequent visits.

# 3. What are scripts?

A script is a piece of programme code that allows my website to function properly and interactively. This code is executed either on my provider's server or on your device.

## 4. What is a Web Beacon

A web beacon (also called a pixel tag) is a small invisible fragment of text or image on a website that is used to monitor traffic on this website. To do this, various data of your visit are stored by means of web beacons.

# 5. Cookies

#### 5.1 Technical and functional cookies

Some cookies ensure that parts of my website work properly and that your user preferences are remembered when you visit my website next time. By placing functional cookies, I make it easier for you to visit my website. I can place these cookies without your consent.

# 5.2 Social media buttons

On my website, I have added buttons for social media, such as LinkedIn, to support web pages (e.g. "Like", "Pin") or sharing (e.g. "Tweet") on social networks such as LinkedIn. These buttons use a code that comes from the social media themselves. This code places cookies. These social media sites may also store and process certain information so that personalised advertising can be displayed to you.

Please read the privacy statements of these social networks (which may change regularly) to learn how they handle your (personal) data that they process using these cookies. The retrieved data are anonymised as far as possible. Some of these networks have their headquarters outside the EU.

# 7. Consent

# 8. Your rights concerning your personal data

- Right of correction: You have the right, whenever you wish, to have your personal data completed, corrected, deleted or blocked.
